

He looked like Hitler after World War II?

Mike 215 forum "History Channel" told the following story: "I had a friend who in 1992 worked at JFK airport in New York. One night, he had nothing to do, so he decided to play a computer by which to identify the passengers.

The Red Army was approaching - it was several hundred meters from the bunker. Berlin trembled and disintegrated from the explosion.
